1. Reference is made to your memorandum dated 28 February 1957 wherein a covert security approval was requested to enable the Subject's conversion from contract agent to career agent status for use as principal agent for Project AC ~~AI~~ in Cuba under [redacted]. Reference is also made to our memorandum of 2 April 1957 in which a provisional covert security clearance was granted for the above use.

2. In accordance with the provisions set forth in the Director's Memorandum of 11 February 1949 entitled, "Security and Operational Clearances," a covert security clearance is granted for the use of the Subject, as described in your request as set forth in paragraph 1, above.

3. This clearance is contingent upon the following:

a. The receipt by this office of full overseas traces and such actual overseas investigation as is possible on Subject and on his wife and her family.

b. that Subject be afforded a polygraph interrogation as soon as possible and that the verbatim results be promptly furnished to this office. The Office of Security will be happy to assist in arranging this interrogation.

4. Subjects of covert security clearances are not to represent themselves as, nor are they to be represented as, employees of CIA.

5. Your attention is called to the fact that a covert security clearance does not constitute complete compliance with the provisions of CIA Regulation 10-215. Therefore, if you should desire at a later date to change the status or use of this individual, a request for clearance to cover any proposed change should be submitted to this office.
