1. INFO REF A PASSED LNERGO 28 FEBRUARY 1969. NO INFO SUBJECT'S FILE SUBSEQUENT DIRECTOR 06625 DATED JUNE 1968, EXCEPT FOR PARA 3 BELOW.

2. SUBJECT HAS NEVER HAD ANY WOFIRM CONNECTIONS. NO EVIDENCE ANY CURRENT LNHPAR RELATIONSHIPS (ISR HAS NO RECORD). PAST HISTORY INDICATES HE FABRICATOR AND MENTALLY DISTURBED INDIVIDUAL.

3. NOT PREVIOUSLY REPORTED WAS FACT SUBJECT SERVED JAPAN EARLY 1958 WITH 441ST CIC DETACHMENT. WAS RELIEVED CIC DUTIES IN APRIL 1958 DUE MENTAL INSTABILITY AND CLEARANCES REVOKED. JUNE 1968 LINGOLD REQUESTED WOFIRM TRACES ON SUBJECT AND REFERRED TO LNERGO. PRESUME THIS REQUEST STEMS FROM HIS APPROACH AMCONGEN ZURICH JUNE 1968 AND DETAILED INFO ALREADY KNOWN CONSULATE.
