SUBJECT: Request AMBLEDY/1 Make Anti-Castro Tape Recording

29 June 1960

ACTION REQUESTED: See Below

1. The AMYUN organization reports it has the capability of playing tape recordings over selected public address systems in some of the most popular places in Habana. In order to test this professed capability and perhaps at the same time obtain some positive MCASE results, it is requested that MASH request AMBLEDY/1 to record a series of anti-communist speeches for replay in Habana. The AMBLEDY/1 recording should run approximately twenty minutes and it is suggested that the twenty-minute recording be broken down into four separate speeches, each of five minutes duration.

2. The Station leaves the subject matter of the speeches to MASH discretion but would like to suggest that in one of the speeches the overall theme of a large and growing organized resistance within Cuba be emphasized in some fashion. Another useful theme would be a call for general and organized resistance to the Khrushchev visit by all anti-Castro elements.

3. If time and the present work load at MASH permit, the Station would appreciate having at least three copies of each tape produced by AMBLEDY/1 for possible simultaneous transmissions on a given date.
