2. AMCLATTER 4 ^{D3} [(PEDRO FERNANDEZ)] DEPARTED HAVA FOR MASH 19 AUG. STATION CONTACT NOW AMCLATTER 3 WHO REQUIRED ADDRESSES OF ALEJANDRO RAMON AND BROTHER. AMCLATTER 4 WAS ASKED BY STATION TO OBTAIN ADDRESS AND BIO DATA EARLY BUT LEFT PRIOR TO PASSING INFO TO STATION.
