1. LOCAL LNERGO HAS ASKED FOR STATION TRACES ON RICHARD CAIN AKA RICHARD SCALZETTI, DPOB: 4 OCT 1931, CHICAGO, ILLINOIS.
2. ACCORDING TO LOCAL LNERGO, PILOT OF EASTERN AIRLINES PLANE SKYJACKED AND FORCED TO FLY TO HONDURAS, 5 MAY, SHOWN PHOTO OF CAIN AND IDENTIFIED HIM AS SKYJACKER. LNERGO STATES CAIN IN MEXICO CITY ABOUT 15 APRIL 1972, RETURNED TO CHICAGO, AND DISAPPEARED ABOUT 1 MAY SAYING HE GOING TO LATIN AMERICA.
3. CAIN ALLEGEDLY INVOLVED IN ILLEGAL INTERNATIONAL ARMS DEALS AND ON VARIOUS OCCASIONS STATED HE WORKING FOR BKTRUST.
4. STATION HAS NUMEROUS TRACES ON RICHARD S. CAIN, DATING BACK TO 1969'S, MOSTLY IN RELATION TO LNERGO QUERIES. LATEST INFO IN FILE DATED OCT 1970 WAS REPLY TO QUERY FROM EMBARGY SECURITY OFFICER IN FORM OF MEMO RESPONDING TO REQUEST FOR TRACES ON LUZ MARIA SEVELLA SANTILLAN DE CAIN AKA LUCY CAIN.
