Unless advised to the contrary by cable, WAVE will supply CONTE the \$1000 promised him for the support of his book being published in Miami.</p> <p>4. Wednesday September 20, 1961

- 1- Conte met with Miro for three hours. Miro ratified that he wanted Conte to join the council and proposed no conditions. Neither did Conte. Miro asked Conte to answer him on Friday Sept. 22.

Miro also told Conte that an "American" was coming down to Miami to take charge of all affairs here and that he would work in close contact with him (Miro). He also told Conte that the power of the Key West station would be increased and that directional antennas would be installed. He (Miro) wanted Conte to address the Cuban people over that station. He also said that he was getting full backing (from Amer. Govt.) in all matters and that he (Miro) would be in full charge of all military and propaganda matters.

Miro told Conte that he had asked the following to form part of the council:
 Directorio Estudiantil Revolucionario.
 Frente Obrero, FURDC (they must appoint three from which he will choose one)
 One professional man (not named)
 Eino Diaz
 George Sotus
 Conte

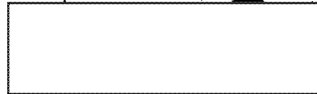
- 2- Conte told me that if he gets backing from the Govt. for him and his group he will not join the council. If he does not get backing then maybe he will join after all (he hasn't made up his mind.) By backing he means military and economic, for his group which is called Frente Anticomunista Cristiano. This seems to have been promised by XXXXX Martin
- 3- Has the Uruguay book been printed yet? The name of the book is, "Alianza de la Libertad", and was entrusted to Alfredo Perez Lagrave in Uruguay. 10,000 books were supposed to be printed but as yet he has heard nothing on this matter.
- 4- Miami book, "America Contra el Comunismo", 10,000 are being printed and ~~xxxxxxx~~ should be finished within ten days. He was given \$2000.00 but is still owed \$1000.00.
- 5- Conte is worried about income tax on the \$3000.00 he is getting for his WHUL program and wants to know what to do about it. (what he really wants is to get out of paying it.)
