1. FOLLOWING AFTER CONVERSATION WITH BUNKER AND BENNETT: **AMCORE-2**  
 NOW VISITING WITH OAS COMMISSION (1645 LOCAL). HE HAS ADVISED THE COMMISSION "THAT SOMETHING WILL HAPPEN" AT 1900 LOCAL (IMBERT IV RESIGNATION).

AND THAT IF COMMISSION WILL BE AT THEIR HQS "SOMEONE" (IMBERT) WILL VISIT COMMISSION AT 2130 LOCAL.

2. PROBLEM: INCREDIBLE AS IT MAY SEEM, **AMCORE-2** PRESSED IMBERT INTO ADVANCING RESIGNATION BY ANNOUNCING THAT IT NECESSARY THAT HE (**AMCORE-2**) AND ENTOURAGE HAD IMPORTANT BUSINESS IN FLORIDA ON 31 AUGUST. BUNKER, WHO ATTEMPTING COMPLETE NEGOTIATIONS SOONEST, VERY PLEASED. DURING MEETING WITH OAS **AMCORE-2** ADVISED THAT CHARTERED DOMINICAN AIRCRAFT BROKEN DOWN. BUNKER AGREED THAT OAS WOULD ATTEMPT TO HELP. AT THIS POINT BUNKER LEFT MEETING TO CONTACT [ ] SAID HE WISHED KUBARK ASSISTANCE IN OBTAINING AIRCRAFT FOR MORNING 31 AUGUST, SUGGESTING [ ] REQUEST PLANE FROM GENERAL PALMER. [ ] ADVISED AGAIN<sup>S</sup> THIS. IN LATER DISCUSSION WITH BENNETT HE MOST EMPHATICALLY AGREES **AMCORE-2** AND TROUPE SHOULD NOT TRAVEL ON USG AIRCRAFT. PRIVATE AIRCRAFT SHOULD BE OBTAINED FOR TRIP. WISH TO CARRY THROUGH IF POSSIBLE. BUNKER BELIEVES AMCOE-2 TRIP AND EFFORTS [ ] TOO GOOD TO BE TRUE. AND WISHES, AS DOES [ ] TO GET AMCOE-2 OUT OF COUNTRY WHILE WE ARE SO FAR AHEAD OF THE GAME.

3. CAN WAVE ARRANGE CHARTER DC-3 OR OTHER APPROPRIATE AIRCRAFT TO DEPART WAVE EARLIEST HOURS 31 AUGUST FOR ROUND TRIP TO MIAMI? [ ] CAN HANDLE LANDING AND REFUELING PROBLEMS. PERHAPS "BUSINESSMAN FRIEND" OF AMCOE-2 COULD MAKE APPROACH, PLAYING IN ADVANCE? LATER TONIGHT (30 AUGUST) [ ] MIGHT ARRANGE LONG-DISTANCE CALL FROM AMCOE-2 TO "FRIEND" FOR COVER PURPOSES. OR IS WAVE IN CONTACT WITH SECOND PERSON IN AMCOE-2 GROUP WHO COULD ARRANGE? LEAVE TO WAVE DISCRETION BEST AND MOST RAPID METHOD IMPLEMENTING ABOVE.
