LABELS WITH ANCORE-2'S ADDRESS WERE PASTED OVER HUNGARIAN ADDRESS, PRESUMABLY IN HAVANA POST OFFICE, AND RECEIVED BY MANAGER OF WKUL DEPT IN NEW YORK. CONTENTS NOT SIGNIFICANT AND PACKAGE WILL BE RETURNED TO BRENT FOR FORWARDING TO ANCORE-2. HQS INTERESTED WHETHER PACKAGES RE-DIRECTED SPONTANEOUSLY BY GOVT EMPLOYEES WHO HAD HEARD ANCORE-2'S BROADCASTS OR ANCORE-2 HAS ARRANGEMENT WITH CONTACT IN CUBA. SUGGEST WILLIMON TELL ANCORE-2 HE UNDERSTAND A-2 MAY HAVE RECEIVED DIVERTED MAIL AND OBTAIN DETAILS ANY ARRANGEMENTS. IMPORTANT THAT A-2 NOT MAKE SUCH REQUESTS BY RADIO AT THIS TIME.
