Subj is considered by friends to be anti-Communist and also rather critical of the USA. First contact with Subj by a KUBARKER was during a meeting in Mexico City on 9 March 1961. This meeting was arranged by Subj good friend, Carlos TEPEDINO, Cuban dissident now in jewelry business in NYC. 04 also a good longOtime acquaintence the staffer vas W. of TEPEDINO s. The meeting was merely "to exchange views on Cuba", understood this. S, bj admitted and Subj made certain that bousever that trouble in Cuba town was the PSF and the manner in which made no commitments they were influencing Cuban govt today. but did offer, if Subj should so desire, listen to whatever Subj had to say in the future and to offer what aid was within his power.
