1. COS HAD UNSCHEDULED MEETING WITH <sup>021</sup>HUMAIL 4 MAY. <sup>021</sup>HUMAIL SAID THAT HE AND BETANCOURT WERE SUCCESSFUL IN SETTLING DIFFERENCES BETWEEN SANCHEZ ARANGO AND TONY VARONA. <sup>1</sup>HUMAIL FAVORS UNITY BETWEEN LATTER TWO AND <sup>2</sup>AMMAIL AND FELIPE PASOS. <sup>02</sup>
2. <sup>021</sup>HUMAIL BELIEVES GOVERNMENTS IN EXILE ARE OUT-MODED AND SUGGESTS THAT INTERNATIONAL RECOGNITION WOULD BE DIFFICULT AT THIS TIME. INSTEAD HE FAVORS A CLANDESTINE GOVERNMENT BUT WOULD NOT SAY WHERE IT SHOULD BE LOCATED. <sup>021</sup>HUMAIL BELIEVES FIDEL CASTRO NOT YET RIPE FOR OUSTING BECAUSE HE STILL HAS CONSIDERABLE MASS SUPPORT.
3. PRES BETANCOURT TOLD <sup>021</sup>HUMAIL THAT ODYOKE NOW WANTS TO TAKE MEASURES AGAINST TRUJILLO. <sup>021</sup>HUMAIL WILLING TO FORGET NICARAGUAN PROBLEM FOR PRESENT TIME IN ORDER TO APPLY HIS FULL EFFORTS AGAINST TRUJILLO. <sup>021</sup>HUMAIL ASKS IN WHAT WAY HE MAY COOPERATE.
4. COS HAS SCHEDULED LENGTHY <sup>021</sup>DTRACCOON TALKS WITH <sup>021</sup>HUMAIL ON 9 MAY. SINCE SUBJECTS DISCUSSED FOREGOING PARAGRAPHS CERTAIN TO BE ON <sup>021</sup>HUMAIL'S MIND, REQUEST HEADQUARTERS INSTRUCTIONS BY COB 9 MAY AT LATEST.
