FOLLOWING IS SUMMARY DEVELOPMENTS ON EVACUATION MARCOS DIAZ LANZ:

1. MERTON TRAVELED HABANA-TAMPA AND RETURN 20-21 JULY AND REPORTED AMBROO AGREED INFILTRATE SUBJECT 25 JULY. ARRANGEMENTS LAID ON WITH COURAGE ON BASIS PATRICK I, KARENEY WILL MEET BOAT TAMPA EARLY 27 JULY. COURAGE FELT KUJUMP ASSISTANCE IN MIAMI NOT NECESSARY AND THEREFORE THEY NOT MADE WRITING.

2. [redacted] AND [redacted] CONTACTED SUBJECT NIGHT 19 JULY AND REPORTED TO STATION HE IN GOOD SHAPE BUT EXTREMELY NERVOUS AND SCARED. CONTACT ARRANGEMENTS WERE SET UP BY [redacted] WITH [redacted] FOR TRANSFER SUBJECT TO EMERGENCY (S. CHANTER) WHO WILL TAKE HIM TO STATION SAFEHOUSE EVENTG 23 JULY. AT STATION'S REQUEST MURICZ SPECIALISTS ON DOCUMENTATION AND WISCONSIE BYD WASHINGTON FOR HABANA 22 JULY AND JOIN ZANCA MIAMI EARLY MORNING 23 JULY. ZANCA WILL CARRY DOCS AND KIT MIAMI-HABANA. STATION FEELS DELIVERY NECESS BY FOR SECURE TRANSFER SAFEHOUSE TO BOAT.

3. <sup>03</sup> [BYERS] AND <sup>03</sup> [WILLIAMS] ALSO REPORTED AFTER 19 JULY CONTACT THAT SUBJECT CONCERNED OVER SAFETY WIFE AND TWO DAUGHTERS AND WILLING SEND THEM WEST BUT HAD NO FUNDS. HE UPSET SHE REFUSED PBPRIE VISA. STATION REPORTED WHEN SHE APPLIED FOR TOURIST VISA 8 JULY SHE WAS REFUSED BECAUSE OF SUBJECT'S "POLITICAL EXILE STATUS" (CONSPICUOUSLY UNWARE SUBJECT STILL IN CUBA) AND "INSUFFICIENT GUARANTEE" SHE WOULD RETURN CUBA AND NOT SEEK POLITICAL ASYLUM PBPRIE. STATION BELIEVES BEST WAY ASSIST FAMILY IS FOR REBARK TO INTERCEPT HER AT HQS FOR ISSUANCE PBPRIE VISA IN HABANA. HOWEVER, H'S BELIEVES PREFERABLE FAMILY GO MEXI AND H'S ATTEMPT OBTAIN ISSUANCE PBPRIE VISA IN MEXI AFTER SUBJECT'S ARRIVAL PBPRIE. H'S CABLED STATION MORNING 22 JULY IT BELIEVED PREFERABLE FAMILY GO MEXI BUT WOULD GIVE LETTER INSURANCE ~~STATION~~.

4. H'S BELIEVES IT NECESSARY FOR SUBJECT'S SECURE EVICTION THAT HE BE ASSESSED PRIOR HIS EMBARKATION 25 JULY THAT FUNDS AVAILABLE ASSIST HIS FAMILY GO MEXI. IF CASH ON HANDS, H'S PLANS CABLE STATION LEAD 23 JULY AUTHORIZING FOR OF FUNDS (ESTIMATED BY STATION AT 1000 DOLLARS) FOR FAMILY TRAVEL AND SUBSISTENCE FOR 10 DAYS IN MEXI. ~~STATION~~ WILLING TO ASSIST IN OBTAINING VISA PASS.
