2. AUALL-1 - Funds were passed to AUALL-1 by the principal exent for use in the Willi project. However, as conventional political action on the labor front became more and more difficult, these funds used their way increasingly into the MAP war chest since Will-1 was national co-ordinator for this organization. Finally, the taking over of the labor movement by the communists left no road open to opposition elements except that of sabctage and claudestime activity. In April 1961, Gordon Elbadias, principal agent with whom AECALL-1 was in contact was arrested and ultimately deported. There was no further contact with Railiel following the arrest of alkakias. The funds that had been passed to him were presumably used by the haf underground and must have been gone long before the time of Andall-1's errest the end of Captember 1961. Kent, DILL and CCBTS were going commercially, but neither wanted to be sponsored estensibly by the ride. Finally, ChT3 went alone when DIAZ balked at simply being conta's shadow. Reantire, DIAZ Line had begun to debole extensively in exile politics in Mismi, appeared before a comgressional committee and succeeded in making himself useless as a propogenda asset.
