<p>1. On 6 November 1968, LITEMPO-12 was requested to provide information on Subject's present whereabouts and status. LITEMPO-12 reported on 11 November that Subject is living in IDEN D. She is the personal "contact" of LITEMPO-4 and her hotel bills are being paid by the DFS. She was used as the "link" between IDEN C and the students, and apparently continues to maintain a close relationship with IDEN C, in whom the Mexican Government has a continued interest.</p> <p>2. The above information is the most recent available to the Station concerning Subject. Due to the sensitivity of the case, at this time the Station is reluctant to go back to the LITEMPO's unless directed to do so by Headquarters. The Station will keep abreast of the case and advise Headquarters of any new developments.</p> <p>3.
