- JORGE ANTONIO "COKIE" ZIMERI SAFIE, A GUATEMALAN CITIZEN WHO HAS BEEN LIVING IN MIAMI SINCE AUGUST 1575, WAS INVOLVED IN A PLOT TO ASSASSINATE GUATEMALAN PRESIDENT KJELL EUGENIO LAUGERUD GARCIA. THE ACTION WAS TO HAVE BEEN CARRIED OUT 15 SEPTEMBER 1975, BUT ZIMERI WAS WOUNDED IN GUATEMALA CITY DURING AN ARMED ATTACK ON HIS LIFE IN LATE AUGUST 1975 AND WENT TO MIAMI FOR MEDICAL TREATMENT. ZIMERI LEFT GUATEMALA ILLEGALLY AND MAY BE IN THE U.S. UNDER FALSE PRETENSES.Y
- 3. ZIMERI WAS BORN 15 MAY 1944. IN GUATEMALA CITY. GUATEMALA.
