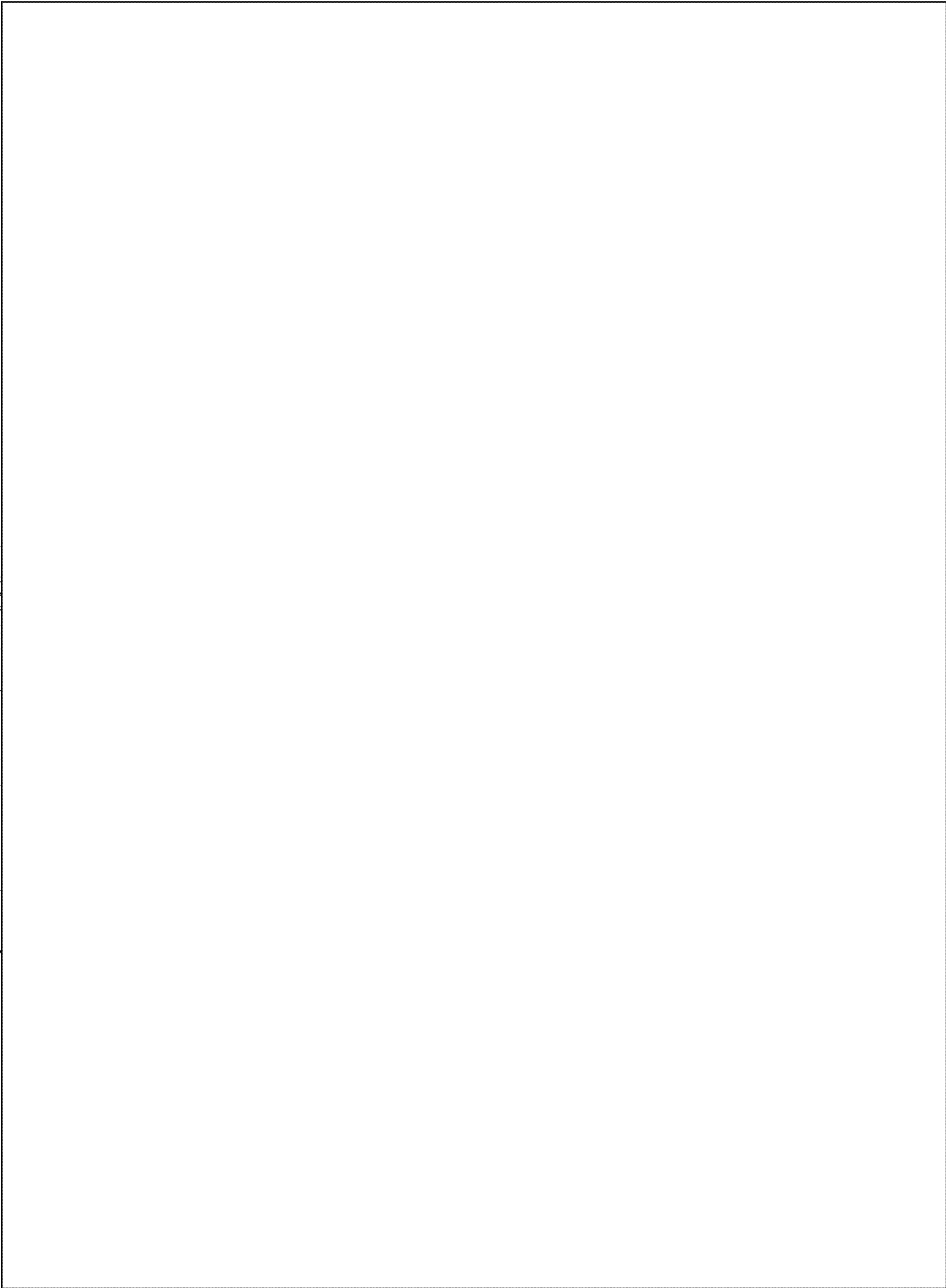

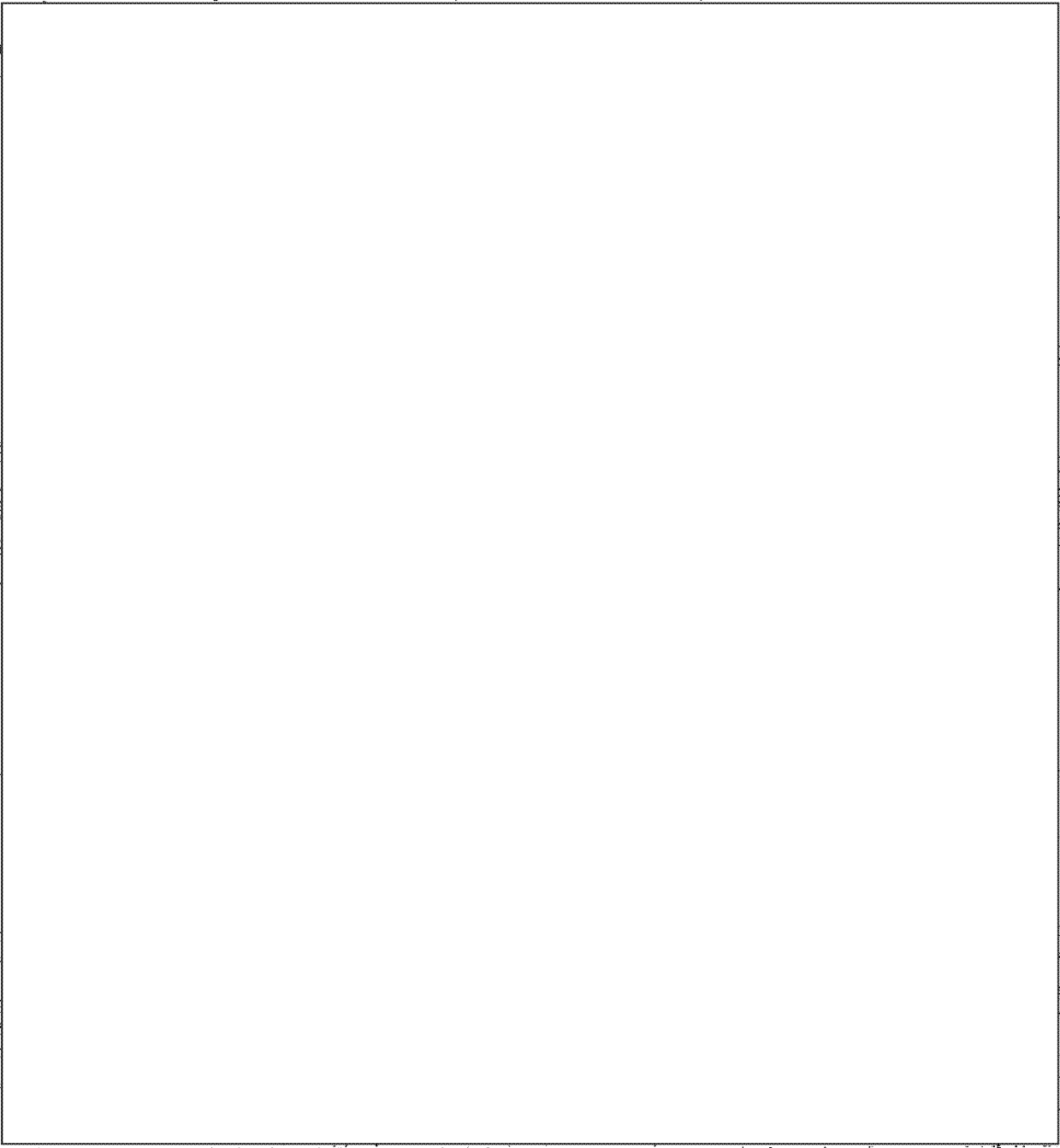

1. On 12 September a meeting was held of stockholders in the ice cream business which functions under the management of the American Communist, Robert STRAND. This business is believed actually to be owned by the leading American Communist, Frederick Vanderbilt FIELD. The meeting was held at the home of STRAND, and was attended by the American Communists Maurice HALPERIN and Noah SEBORER and possibly by other stockholders.

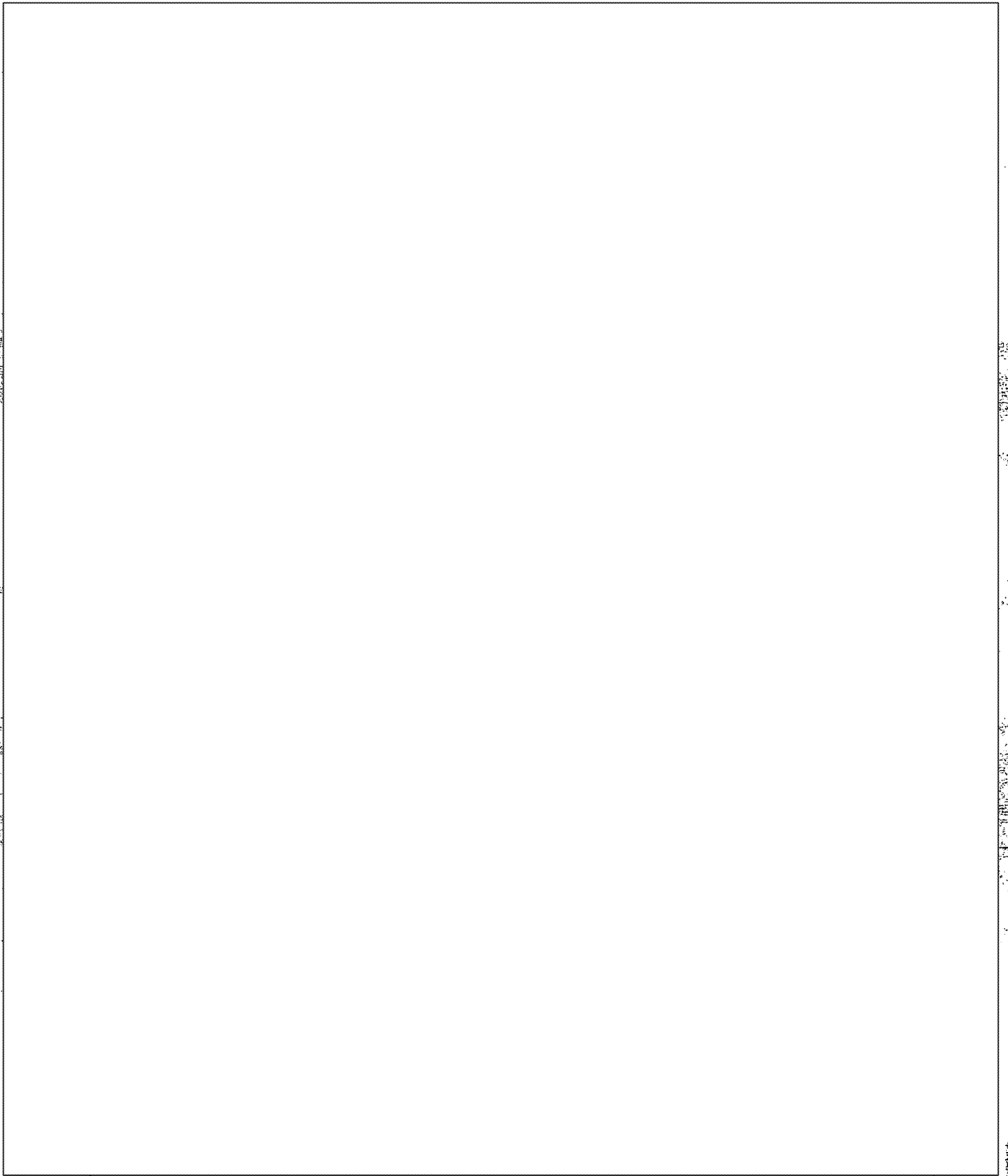
