RYBAT AELADLE

1. ON 8 AUGUST <sup>01</sup>(SMUNHOOK) ASKED ROODINE TO HIS OFFICE WHERE HE THEN <sup>01</sup>INTRODUCED ROODINE TO <sup>01</sup>(SMOTH) CI CHIEF <sup>06</sup>(HINTON). LATTER SAID HE ON SWING THROUGH SCANDINAVIA TO VISIT [redacted] <sup>26</sup>TOLD ROODINE AELADLE NOW IN PEPRIME. RECOUNTED INCIDENTS IN HANDLING AND HIS OWN INVOLVEMENT IN NEGOTIATING FOR AELADLE MOVE TO ENGLAND. REMARKED THAT AT LUNCH WITH <sup>01</sup>[VALINK 1] ON 7 OCTOBER, <sup>01</sup>[VALINK 1] HAD ASKED WHEREABOUTS OF AELADLE WHEREUPON <sup>06</sup>(HINTON) REPLIED THAT HE BACK IN PEPRIME.

2. HE ALSO BROUGHT UP VASSALL AND PAQUES CASES, AELADLE ROLE AND HOW ARRESTS MADE.

3. <sup>01</sup>(SMUNHOOK) RAISED NAME OF <sup>06</sup>[ANNE MARIE SNELLMAN] (SEE <sup>23</sup>[redacted] <sup>19-1</sup>) AND ASKED <sup>06</sup>(HINTON) WHY NOTHING HAS BEEN DONE. <sup>06</sup>(HINTON) APPEARED NOT TO BE FAMILIAR WITH CASE BUT SAID HE WOULD RAISE IT WITH KUBARK. WHETHER HE MEANT IN WASH OR LONDON WAS NOT CLEAR.
