SUBJECT **GENERAL** Operational
SPECIFIC Cuban-Dominican Relations: Senator Rolando MASFERRER

1. On 26 January 1957 Mr. Robert JOHNSON (HDCA-925) informed CGS that the Dominican Government was satisfied that the Cuban Government had clipped Senator Rolando MASFERRER's wings and that this obstacle to Dominican-Cuban cooperation had been eliminated.

2. On 28 January the FEPRIME Military Attache to Cuba and the Dominican Republic indicated that he did not know that MASFERRER's "wings had been clipped". He stated that there was a report that MASFERRER would soon get a cabinet post, adding that MASFERRER was well-liked in Cuba.

3. Will MASFERRER's appointment to a Cuban cabinet post start more Cuban-Dominican trouble?
