WITHDRAWN AS SOON AS POSSIBLE AFTER THE HONDURANS WERE ESTABLISHED IN THE HILLS, WHERE THEY WOULD BE EXPECTED TO LOOT FOR THEIR SURVIVAL. MIRABAL WENT TO GREAT LENGTHS TO EXPLAIN THAT THE CUBAN GOVERNMENT MUST NEVER BE INVOLVED PUBLICLY IN THE VENTURE, AND HE DESIGNATED REINA AND ALBERTO Y ROMAN AS PERSONNALLY AND COMPLETELY RESPONSIBLE FOR ANY DISCLOSURES WHICH MIGHT EVER TAKE PLACE. REINA AND ALBERTO Y ROMAN AGREED TO TAKE ANY AND ALL BLAME IN THE EVENT OF CAPTURE. THEY PLANNED TO TRAVEL FROM MEXICO THROUGH CENTRAL AMERICA IN MID-AUGUST 1964 TO ENLIST APPROXIMATELY 25 MEN IN THE VENTURE. IT WAS EXPECTED THAT THE GROUP WOULD BE PRINCIPALLY COMPRISED OF HONDURAN NATIONALS. MIRABAL WARNED REINA THAT NO CUBAN SHOULD BE INCLUDED IN THE GROUP.
