[REDACTED] was held captive in Madrid from 15 to 21 February, 1959 and again during the week of 15 April 1959. [REDACTED] was installed in the Hotel International, Madrid, reportedly has very good relations with King Vittorio of Italy, President MUHAMMAD AI ABIDIN OF TUNISIA, the royal family of Madrid, Thorstein ALVILDA, and SULTAN ALI AS. He also reportedly knows all of the CIA members and has participated in all the CIA meetings which have taken place in Madrid. On 16 December 1958 [REDACTED] was sentenced to life imprisonment for murder and theft. (His victim was a student by the name of Paul WEISS.) On 19 December 1958 [REDACTED] was sentenced to death and loss of all property by the High Criminal Court in Paris for collaboration with the enemy. [REDACTED] is mentioned in the trial of Marshall BREWSTER (7 August 1954) as a close confidant and advisor of Niflani. On 5 December 1955 [REDACTED] married Alice Wilhelmina Schmid (30 November 1933, Hanover, Germany) in Madrid. She is reportedly a doctor. They have since separated and she is now living in Berlin/Hansdorf, Berlinerstrasse 53-55. On 14 December 1955 she was issued a German passport (number 735-55) by the German Embassy, Madrid. [REDACTED] is described as being intelligent and cultivated, but also very effeminate. 1. [REDACTED] was brought to the attention of the CIA by the subject of reference who visited Madrid 1959. [REDACTED] was in Madrid from 15 to 21 February, 1959 and again during the week of 15 April 1959. [REDACTED], who at the time of the February visit was installed in the Hotel International, Madrid, reportedly has very good relations with King Vittorio of Italy, President MUHAMMAD AI ABIDIN OF TUNISIA, the royal family of Madrid, Thorstein ALVILDA, and SULTAN ALI AS. He also reportedly knows all of the CIA members and has participated in all the CIA meetings which have taken place in Madrid. On 16 December 1958 [REDACTED] was sentenced to life imprisonment for murder and theft. (His victim was a student by the name of Paul WEISS.) On 19 December 1958 [REDACTED] was sentenced to death and loss of all property by the High Criminal Court in Paris for collaboration with the enemy. The Subject of [REDACTED] reported to [REDACTED] that during his April visit to [REDACTED] the latter told him that he had recently been visited by NSA officials from West Berlin who had asked him to work for them and to establish his residence in West Berlin. [REDACTED] did not reveal to subject of [REDACTED] what the nature of the work was to be, but he did state that he was going to take up residence at Berlin/Hansdorf, Berlinerstrasse 53 (the residence of his estranged wife). He added that the NSA officials promised to supply him with NSA documentation. [REDACTED] has tried unsuccessfully in the past to get such written documentation. (Note: Although he was born in Luxemburg, [REDACTED] is now a stateless person.)

3. Headquarters and [REDACTED] are requested to supply the station with any information which might be available on [REDACTED]. [REDACTED] station files, only.

4. [REDACTED] Traces are requested on Alice Wilhelmina SCHMID and the address at which she is reportedly living. (Base files, only)

5. [REDACTED] All traces only on Alice Wilhelmina SCHMID and wife, please.
