ALTHOUGH NEITHER MAYORGA NOR ILLAN RECENTLY CUBA THEY CLAIMED CLOSE TOUCH DEVELOPMENTS THERE. CLAIMED NEW RESISTANCE GROUP BEEN ORGANIZED UNDER FORMER MIN. PUBLIC WORKS MANUEL RAY AND THAT GROUP HAD 400 TO 522 MEN WORKING LAS VILLAS PROVINCE. NEW GROUP NOT PART FRD BUT IN TOUCH WITH IT.

2. MAYORGA STATED RESISTANCE MOVEMENT NEEDED HELP FROM ABROAD. HE ANXIOUS RAISE FUNDS AND INTENDED GO WASH TO INFORM STATE DEPT HIS PLANS. TOLD FORNOFF HE WISHED CONTACT THEM IN ADVANCE AND ASK THEIR OPINION AND GIVE THEM OPPORTUNITY ADVISE THEM DROP IDEA IF IT THOUGHT BE BAD ONE.

3. ACCORDING [SMOTH] FORNOFF TOLD MAYORGA THEY GRATEFUL FOR HIS PASSING ON INFO BUT MATTER ONE WHICH HE MUST JUDGE FOR
