Olian met Subject in October 1958 when the latter was head of the Civic Resistance Movement in Habana. Three clandestine meetings were held with Subject prior to 1 January 1959, which, in addition to Olian and Wallace A. Grovery, were also attended by Ignacio L'encosa, a member of NAC (civic resistance) who originally introduced Subject to Olian. Subsequent to 1 January 1959 Subject was given an important post within the revolutionary government and Olian has seen him only twice since then and on a social basis. Subject believes Olian to be a political officer of [redacted] 99</p>		
<p>2. INDICATE WHETHER SUBJECT COULD BE TURNED OVER QUICKLY AND IN A SECURE MANNER TO ANY RESPONSIBLE CASE OFFICER FOR HANDLING. Station has no covert or clandestine relationship with Subject at this time. He is basically friendly to PRRJME <del>was</del> <sup>has</sup> <del>being</del> <sup>received</sup> a grant for special study leave. He considers Olien to have been friendly to the revolutionary cause before it triumphed. He is a dedicated, patriotic Cuban. He is opposed to Communism but has taken no active part in combatting it.

He control exists over Subject. He has not been an agent and has received no remuneration from us.

Prior to 1 January Subject freely discussed revolutionary matters known to him as head of MRC. He did not "supply" information in the sense of an agent-case officer relationship. Since 1 January 1959 he has provided no information of interest.	
3. INDICATE SERVICE FOR WHICH SUBJECT THINKS HE (WILL WORK) (IS WORKING).	
Subject will not be working for us. However, we hope eventually to exploit the political-action potential of Subject by using him to influence government decisions in favor of the United States interests and in opposition to Communist designs.

Only practical training as head of Civic Resistance Movement. The Civic Resistance Movement was largely the "logistic" arm of the 26 of July Movement.
