- 5. AMWHIP/2 speaks Spanish; Cerman, and French fluently but had almost no English or Italian.
- 6. ANNIP/2 then asked if BUNCE's duties would not bring him back to Europe occasionally and thus permit a continuation of the present arrangement, through meetings in coneva or elsewhere in Europe He was told that no definitive answer is possible now and that if such a trip materializes BUNCE will call on him but that he need have no qualms about contact with BUNCE's successor.
- 7. He was asked if he had heard anything further from Antonio Maria CARRILLO Carreris, 201-349956, since the latter's return to Cuba. ANWHIP/2 said that he had not. ANWHIP/2 said calmly that while he was in Benidors he arranged for vacation quarters there for CARRILLO but that CARRILLO, on arrival, did not like the place and the another. He added that he (A/2) and wife left Benidors shortly before CARRILLO arrival and thus did not actually meet him there.
- 8. Reither ANVRIP/2 nor his wife has heard anything further from ANVEST/1.
- 9. Per (OKLW-23055, 11 May 1966 (not to AMUHIP/2 was not given any specific facts about Josef Wilhelm FROTZ. asked if he had seen FROTZ again and said yes. He met FROTZ recently (about 23 May 1966) at the Hilton Hotel. FROTZ said he had been very busy but expected soon to have time for a deal if AMWHIP/2 is interested. It seems that FROTZ's uncle is a bishop in Cermany (as report. 9420, 22 March 1966). The Catholic church is engaged in ed in smultling valuable art objects out of Hungary (and perhaps other European satellites, though AMWHIP/2 does not know the latter as a fact) in order to remain money. FROTZ sets these objects from his uncle and sells them, actually or ostensibly for the church. ANNHIP/2 would like to get into the act, which he believes is lucrative. He explained that FROTZ has on deposit in a bank in Switzerland a cold-colored or gold-plated statue weighing about three kilos and priced at about 25,000 Swiss francs. The statue came from Hungary. AWWHIP/2 thinks he has a buyer. AWWHIP/2 had taken the precaution of checking with a Cerman credit rating outfit in Germany, however, and had learned that FaOTZ had twice been charged with passing had checks. To AMWHIP/2's direct request, BUNCE said only that FROTZ is an East-West trader who seems to have something of a reputation for fraud. AMWHIP/2 said that he would like to try to do business with FROTZ, both because he may be involved in matters of some intelligence interest and because he thinks that he (A/2) could thus make some money. A/2 was no real danker in the association, now that he has been warned and his eyes are open.
- 10. Para, 1 b of CAMA/20049, 3 September 1965 mays that AM#HIP/2's wife told 201-740649 that she had made reservations for the FRNUMEN Connul in tenus in Benidorm and later confirmed the reservations in a personal phone call to the Consul." BUNCE therefore asked AM#HIP/2 if he knows the Cuban Consul in tenus, Esther RORLICUES Colon (201-349956). He could not resember her by name or job Comment. It is believed that his answer was truthful and that he does not apply HORRICUES but that his wife may know her.)

Reference was made above to the presence of AMWHIP/1 in Home, as had also been announced before his arrival by DIRECTOR -16 April 1966. AMWHIP/1 sent preetings to BUNCE via AMWHIP/2. AWWHIP/2 reports that A/1's infaturation with his mistress is stronger than ever and that he is starting to think about a divorce. AMMHIP/2 says that AWWHIP/I's wife is much more attractive than his mistress but that the mistress pays him much attention, whereas the wife tends to ignore him. ANWHIP/2 also reported that during the day of 24 May 1966 ANWHIP/1 and mistress, in a car, were on the Via Veneto and saw a car starting to pull out from the curb. ANWHIP/1 waited for the empty space; but as he did so, another car shot past him and usurped AmeHIP/1 got out of his car and reprimanded the Italian driver. The latter also left his car, words were exchanged, and with a single punch AkwHIP/1 knocked the Italian out. The Italian was unconscious for ten minutes. All involved were taken to a police station. As of 25 May AMWHIP/2 did not know further developments! Onnment: It is essential that the fore oing, which is reported solely a an aid to the continuing assessment of AMWHIP/I, should not be made known to him, directly or by allusion, unless Headquarters has alread received the same information from another source and unless Beadquarters is positive that ANWHIP/1 will not spot or even suspect ANWHIP/2 as the source. It will be recalled that ANWHIP/2 furnished somewhat similar information about AMWHIP/1 on a previous occasion and that when this information was reported, some asked in maked in para. 8 of QIRA 38996, 16 December 1964, that no consequent action be taken which could endanger the source. Whether it was the information contained in CIRA 38996 or something else concerning ANWHIP/1 is not known (because ANWHIP/2 refused to specify) but ANWHIP/2 became convinced (as he still is) that something that he told to BUNC about AMWHIP/1 was repeated to the latter by his Headquarters case officer and that the result was to endanger a twenty-year friendship and long-standing business partnership. (See para. 5 of Olka 31342, 25 August 1965.) If AMWHIP/2 were again confronted by an angry22 AWWHIP/1 and accused of such reporting, AMWHIP/2 would undoubtedly be furious and would sever his relationship with KUBARK.

Rejarding his association with AMLASH/1, AMAHIP/2 repeated the information reported in OIRA 41342. He says that on the occasion reported in that dispatch AMLASH/1 was so drunk that AMBHIP/2 followed him into the bathroom because he feared that he would pass out and perhaps hurt himself. Heferring to AMSHIP/2 and others, who were in the living room, AMLASH/1 said, "They are all sons of prostitutes: You are the only decent man here." As was his curtos, AMWHIP/2 had fone for a long walk as soon as AMLASH/1 and others appeared at AMWHIP/1's apartment. He streamen that he made every effort not to be involved in the plannin, and to know nothing about it and that AMLASH/1 was well-aware of this fact. Only on the reported occasion did ho chance to return before AMLASH/1 and ammociates had left. AMEHIP/2 therefore concludes that if AMLASH/1 mentioned his name at all under interrogation and told the truth, Amenip/2's position visa-vis the retime has not suffered. rank. On three occasions he has stated that he favors violent action in Cuba to overthrow the regime and has requested SUNCE's views. (He has invariably been told that the ratime will to under through its own sins or through internal revolution.) These indicators are minor, and in assessment of most agents would give rise to similar grounds for suspicion. They are nevertheless listed here as an aid to the KUBARK case officer who will take over AMWHIP/2 after BUBCE's departure.)

The contact arrangement explained in para. 4, above, has the defect that ANVHIP/2 is away from Rose for lengthy periods and that contact depends on telephoning him at his Rose store or agent. ment.
