AMHARSH/1 reported on 11 November 1966 that he had seen 06 [redacted] (201-783666) on 10 November 1966 and [redacted] 06 had showed him a letter addressed to his mother [redacted] 06 from [redacted] in PBRUMEN dated 16 October 1966. [redacted] 06 current wife of [redacted] (201-753063), and she writes frequently to her mother-in-law relating news about their family in 06 PBRUMEN. Included in the letter was the brief statement that Milton 06 had told her to have [redacted] tell [redacted] he had received the note from AMHARSH/1, and that soon everything would be arranged. [redacted] 06 [redacted] knows [redacted] is the pseudonym AMHARSH/1 has used in 024 [redacted] contacts, and AMHARSH/1 used this name in the letter to [redacted] which AMJUJU/1 asked him to write.)</p> <p>2. In view of the above AMUUG/1 was queried about the procedures followed by AMSTAFF with reference to walk-ins. AMUUG/1 advised that instructions had been issued to all overseas representatives to treat walk-ins courteously and to show interest in whatever they had to offer. All possible background and personal information was to be acquired by the overseas representative and this information was to be forwarded to AMQUAKE Headquarters for confirmation and analysis. All walk-ins were considered potential sources of information and all were considered to have possible future utilization. AMUUG/1 claimed that information forwarded to AMSTAFF Headquarters was screened and sent to the desk officer for the specific area where the walk-in would probably work if recontacted. It was the responsibility of the desk officer to check all available information and to make a determination</p>

if the walk-in could be used and should be recontacted. AMJUC/1 estimated the time involved from the date of walk-in until recontact would probably be at least four months or more.

3. Obviously AMSTAFF has received AMJUC/1's AMHARSH/1 walk-in report, and they are probably in the process of making a determination on AMHARSH/1's case.

4. As indicated previously in paragraph 6 of reference B, JMWAVE has been reviewing the AMHARSH/1 operation for some time from the standpoint of its cost (\$7,500 per year) in relation to AMHARSH/1's access to hard intelligence and operational information, and his actual production. At this time the walk-in phase of the operation appears promising; however, his access to any hard intelligence is now nil, and his production of operational support information has dwindled to infrequent marginal reports. Thus he is of no further operational use to JMWAVE unless he is recontacted and utilized by AMQUAKE, and our experience in this type operation has shown us that utilization by AMQUAKE can be a long, drawn out affair before any tangible results are achieved.

5. Therefore, JMWAVE is initiating actions to terminate as of 30 April 1967 (expiration date of current JMWAVE deposit to the cover company) AMHARSH/1's salary and cover employment. We have advised AMHARSH/1 of the probability that he will be terminated, and he is now in the process of seeking other employment in the JMWAVE area where he wishes to remain. After 30 April 1967 our contact and financial arrangements with AMHARSH/1 will depend upon the status of his contacts with AMSTAFF. A change of employers by AMHARSH/1 should have no great effect on AMSTAFF's interest in him, since AMSTAFF is aware from AMJUC/1's walk-in report that AMHARSH/1 was dissatisfied with his cover company position.

6. On 13 September 1966 AMHARSH/1 was scheduled to be given a SCSWIRL examination. On arrival at the examination site he claimed to have a slight head cold, and the SCSWIRL began on the basis that the slight cold might not interfere with the results. However, as the examination progressed it became apparent AMHARSH/1 was suffering from more than a slight cold, and inconclusive SCSWIRL results were being obtained. Consequently, it was decided to discontinue the examination and reschedule it when his health was better.

7. On 15 September 1966 AMHARSH/1

another SCSWIRL examination has been scheduled for 20 December 1966.

8. JMWAVE will promptly advise Headquarters of all important developments in the AMHARSH/1 operation.
