"Rafael" works in the MI Department (Department of Technical Operational Support) of the Direccion General de Inteligencia (General Directorate of Intelligence - DGI) and is one of the secret writing technicians who deciphers correspondence from agents. "Rafael" is the nephew of Guillermo ARASTAGUIA (Subject of CSCI-316/00643-64 of 11 August 1964).<sup>1</sup>

Headquarters Comment

1. The above Subject is not identical with the Subject of CSCI-316/00430-65 of 2 February 1965. The records of this Agency reveal no identifiable information on "Rafael."
