Source, although he does not know Osmin FERNANDEZ Concepcion, heard that FERNANDEZ was going to be assigned to the Direccion General de Inteligencia (General Directorate of Intelligence - DGI). According to source, FERNANDEZ, who is somewhat effeminate, is a friend of Manuel PINEIRO and Cesar CUENCA.

Headquarters Comment

- Aside from the information included in the above referenced report, the records of this Agency reveal no additional identifiable information on Osmin FERNANDEZ Concepcion.
