1. "Carmen" is a secretary in the XI Section (Department of Technical Operational Support) of the Direccion General de Inteligencia (General Directorate of Intelligence - DGI).

2. "Carmen" was born between 1943 and 1945, is five feet five inches tall, weighs between 110 and 115 pounds, and has a thin build. She has a white complexion; long, reddish hair; brown eyes; a thin face and lips; a small mouth; and white, uniform teeth.<sup>1</sup>
