### Headquarters Comments

The following report is one of a series containing personality information provided by the source and includes supplemental information from the records of this Agency.

It is requested that the addressees take no action on any of the individuals mentioned in the personality reports without first checking with this Agency.

1. "MAYRA" is the secretary of Guillermo ARASTAGUIA, chief of the MI Section (The Department of Technical Operational Support) in the Direccion General de Inteligencia (General Directorate of Intelligence - DGI).

2. "MAYRA," whom source believes to be a Cuban citizen, was born between 1940 and 1945, is about five feet eight inches tall, weighs approximately 120 pounds, and has a thin build. She has a white complexion with red cheeks, blond hair, and green eyes. She has a small, straight nose; a small chin and mouth; a thin face and thin lips; a long, thin neck; and even teeth.<sup>1</sup>
