- "Vidalina" is the secretary to Manuel PINEIRO Losada at the Headquarters office of the Direccion General de Inteligencia (General Directorate of Intelligence - DGI).
- "Vidalina," believed by source to be a Cuban citizen, was born about 1930. She is five feet seven inches tall, weighs 125 pounds, and has a medium build. Her complexion is white and her hair is brown with some grey.
- "Vidalina" is the wife of "Contreras" (an alias), head of the Laboratorio Quimico (Chemical Laboratory - LQ) of the MI Department (Department of Technical Operational Support) in the DGI.

Headquarters Comment

- The records of this Agency reveal no identifiable information on "Vidalina."
