The following report is one of a series containing personality information provided by the source and includes supplemental information from the records of this Agency.

It is requested that the addressees take no action on any of the individuals mentioned in the personality reports without first checking with this Agency.

1. Gustavo LNU, aka "Lino," is an official of the Departamento Ilegal (Illegal Department) in the Direccion General de Inteligencia (General Directorate of Intelligence - DGI).

2. Gustavo LNU is a Cuban citizen and was born about 1937 or 1938. He is six feet tall, weighs 140 pounds, had a thin build. Gustavo's ethnic type is Latin; he has a dark complexion, black, wavy hair which he wears in a ducktail, small, black eyes, thick eyebrows, a thin, straight nose, a large, thin face, and a long thin neck. He has thin lips and a small mouth which appears to be disfigured when he talks and laughs. Gustavo resides at Calle 20 de Mayo, number 428, Apto 74, Habana.
