 GO J OFFICES ANILIA PEREZ GOMEZ AKA "NELA" NAVARINO, CHILEAN
 NEWSPAPER WOMAN. *assist* [Redacted] SAID ANXIOUS GET OUT DOMESTIC AND
 ABLE CONVINCED REBELS HIS LIFE ENDANGERED BY LIBERT FORCES.
 GAVE "LIFE" PHOTO AS REASON HE BEING PURSUED. CLAIMS HE STILL
 CLEAN ALTHOUGH JUAN JOSE AYUSO CRITICAL HIS DEPARTURE, CALLING
 HIM COWARD. *assist* [Redacted] SAID FAILURE CONTACT [Redacted] ATTRIBUTABLE
 TELEPHONES OUT OF ORDER HIS ZONE AND AWAITED CASE OFFICER CONTACT
 AFTER HIS RESIDENCE TAKEN OVER BY LIBERT FORCES. HOWEVER, *CIA OFFICER* [Redacted]
 BELIEVES FEAR MAY HAVE BEEN OVERWHELMING FACTOR THIS CASE AND HIS
 TAKING ASYLUM RESULT SAME FEAR. HE NOW VERY HAPPY NEW YORK AND
 ANXIOUS GET WIFE AND CHILD TO UNITED STATES. WHEN FAMILY IN

B. ACCORDING AMELIA PEREZ GOMEZ, CAAMANO GOVT USING CHILEAN EMBASSY CODE ROOM SEND MESSAGES RUBEN BRACHE IN NEW YORK. PEREZ, ACCORDING *asset* 2, IS FREI SUPPORTER AND VERY MUCH ANTI-UNITED STATES. CARLOS SOUPER-SOTA, CHILEAN CHARGE IN SDON, IS SUPPORTER ALLENDE.

C. RAFAEL "FAFA" TAVERAS ROSARIO IN PRESENCE *asset* AGGRESSIVELY CHIDED CAAMANO FOR ARREST APCJ MEMBER AND DEMANDED HIS RELEASE IMMEDIATELY. PRISONER RELEASED WITHIN FEW HOURS.

D. EDGAR ERICKSON, WHO WENT CUBA FEW YEARS AGO, IS FROM SANTIAGO AND NOW THERE. ERICKSON, WHO RELATIVE ERICKSON ALVAREZ BROTHERS, IS MEMBER MPD AND CLOSE TO MAXIMO LOPEZ MOLINA.
