 MOVE RAPIDLY AGAINST ALL ~~LEADS~~ <sup>CUBAN DEF</sup> LEADS. IN VIEW POLITICAL SITUATION IN SEVERAL  
 COUNTRIES THROUGHOUT AREA (D.O., CHILE) INTENS MUST BE DESIRABLE TO SURFACE SOON  
<sup>CUBAN DEF</sup> INFO, INCLUDING DOCUMENTS, TO YOUR LOCAL 24 YOU SHOULD BE  
 ADVISED TO SURFACE ALL ~~INFO~~ <sup>CUBAN DEF</sup> INFO IN YOUR POSSESSION, REGARDLESS OF CLASSIFICATION,  
 EXCEPT THAT NOTED IN PARA FOUR BELOW. HQS WILL GIVE AS MUCH ADVANCE NOTICE AS POSSIBLE
