1. WE HAVE BEEN EXPERIENCING DIFFICULTY IN GETTING AN OFFICIAL TO ASSIGN ADDITIONAL MEN TO THE NYXIS TEAM. TOLD US SOME TIME AGO THAT THE TEAM WOULD BE INCREASED BY 3, BUT SO FAR HE HAS FAILED TO COME THROUGH. THE ADDITIONAL WORK LOAD REQUIRED BY THE PRESENT TEAM HAS CAUSED A PROPORTIONATE DECREASE IN THE AMOUNT OF TIME THE TEAM CAN WORK ON THE CUBAN TARGET. BECAUSE WE WERE TOLD THAT WHEN THE TEAM MEMBERSHIP IS INCREASED WE WILL HAVE ONE MAN TO WORK EXCLUSIVELY ON THE CUBAN TARGET, WE ARE, OF COURSE, ANXIOUS FOR AN INCREASE IN PERSONNEL.

2. WE ASK THAT AVAILABLE INFORMATION ON THE CUBAN IS AND HOW IT FUNCTIONS IN COUNTRIES WITH WHICH CUBA HAS DIPLOMATIC RELATIONS BE COMPILED IN A SANITIZED MANNER FOR PASSAGE TO [redacted] BECAUSE WE KNOW THROUGH [redacted] THAT EMBASSY PERSONNEL ARE IN TOUCH WITH THE JCP. IT WOULD ALSO BE HELPFUL TO HAVE A STUDY AS TO WHAT EXTENT CUBAN IS TYPES UTILIZE CP'S OF THE HOST COUNTRY FOR OPERATIONAL PURPOSES. IT IS HOPED THAT THIS INFORMATION WILL HAVE THE DESIRED EFFECT OF MAKING HIGH-LEVEL OFFICIALS AWARE OF THE THREAT POSED BY THE CUBAN IS, AND CUBANS IN GENERAL, WITH THE FURTHER WISH THAT THIS INFORMATION WILL REACH HIGHER GOVERNMENTAL ECHELONS, AND INFO ASSIGNING THE EXTRA 3 MEN TO THE NYXIS TEAM.
