FIELD REPORT NO. UFG-7678

AN EDUCATED CUBAN EMIGRE IN THE PUBLIC INFORMATION FIELD WHO RECEIVES A STEADY FLOW OF CORRESPONDENCE FROM CUBA AND HAS MANY CONTACTS IN THE EMIGRE COMMUNITY. SOURCE'S REPORTING IS CONSIDERED TO BE GENERALLY ACCURATE. IT APPEARS THAT THIS INFORMATION WAS GIVEN TO THE SOURCE IN THE HOPE THAT IT WOULD REACH THE U.S. GOVERNMENT.

1. ON 26 OCTOBER 1965 ORLANDO BOSCH AVILA, HEAD OF THE MOVIMIENTO INSURRECCIONAL DE RECUPERACION REVOLUCIONARIA (MIRR, INSURRECCIONAL MOVEMENT FOR REVOLUTIONARY RECOVERY), SAID THAT HE HAS "ALL THE EQUIPMENT NECESSARY" TO DESTROY THE ARRECHABALA REFINERY IN CARDENAS, MATANZAS PROVINCE, WHICH IS VERY CLOSE TO CAMARIOCA. (FIELD COMMENT: IT WAS RECENTLY REPORTED THAT THE REFINERY WAS ONE OF THREE TARGETS WHICH THE MIRR IS CONSIDERING ATTACKING IN AN ATTEMPT TO DISRUPT THE FLOW OF CUBANS FROM CAMARIOCA.) BOSCH FEELS THAT IF THE MIRR CAN EFFECT THIS OPERATION, FIDEL CASTRO
