

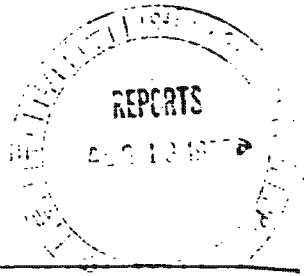

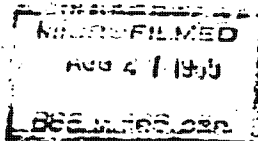

Field Comments:

1. Guede may be identical with Emilio Guede Fernandez, an associate of Ray of long-standing.
2. del Porto may be identical with Heriberto del Porto Rios who until May 1963 was a coordinator in Cuba for the Movimiento Revolucionario del Pueblo (MRP, Revolutionary Movement of the People), an exile organization formerly headed by Ray.
3. Orta may be identical with Martiniano Orta Ceballos, a Cuban physician in Miami who has been associated with emigre activities.
4. Acosta may be identical with Orlando Acosta Suarez, who has been associated with JURE.
