1. ABOUT 1900 HOURS 12 JAN DEGRIP WENT TO BLDG, SAW EIGHT NUMBERED LETTER BOXES ON RIGHT SIDE JUST INSIDE ENTRANCE. NONE BORE NAME PLATES. MADE QUICK RECON OF TOP FLOOR WHERE APARTMENTS SEVEN AND EIGHT LOCATED, NEITHER HAD NAME PLATE. ONLY PERSONS SEEN IN BUILDING PAIR OF NECKING LOVERS SECOND FLOOR WHO PAID NO ATTENTION TO D.
2. D PHONED FROM PUBLIC PHONE IN RESTAURANT ABOUT 1930 HOURS USING NUMBER FURNISHED BY HQS. RECORDED ANNOUNCEMENT SAID NUMBER CHANGED. GAVE NEW NUMBER (D WILL FURNISH) WHICH D CALLED. CUBAN GIRL WITH HEAD COLD ANSWERED. USING CUBAN ACCENT D ASKED FOR [REDACTED] WAS TOLD SHE NOT IN TOWN, VISITING IN INTERIOR, EXPECTED RETURN WITHIN TEN DAYS. D ASKED NUMBER OF APARTMENT, WAS TOLD EIGHT.

5. D HAS STASHED PILLS IN CERA BRAND TOCLOID MEDICINE BOTTLE
