1. BACKGROUND THIS CASE TOO EXTENSIVE TO RELAY. HOWEVER, PLAN HAVE JOSEPH LANGOSCH, WHO BEING ASSIGNED FRAN AS PBRUMEN REGIONAL REP. VISIT [ ] TO BRIEF PRESLAND, PROBABLY IN AUGUST.
