1. 30 DEC AMPALM-5 ASKED [Redacted] IF HE DID NOT AGREE THAT
 MOMENT TOO CRITICAL AMPLIFY AMPORT, SUGGESTING BROAD REPRESENTATION
 COULD BE ACHIEVED LATER IN PROVISIONAL
 CABINET.

2. [Redacted] REFERRED AMPALM-5 TO MONTHS OF DISCUSSION THIS
 SUBJECT PLUS 19 DEC MTG WITH BENDER WHEN ENLA GENENT APPARENTLY
 AGREED ON. SAID ON CONTRARY, THAT MOMENT MORE PROPITIOUS
 THAN EVER, STARTING WITH ELECTION MANUEL CAGO TO FILL SEAT LEFT
 VACANT BY AMEER. AMPALM-5 ACCEPTED VIEW JOYLESSLY.

3. COMMENT: VIEW QUERY AS TRIP-BALLOON BY AMJAG WHO AS
 WEAKEST MEMBER AMPORT HAS FORMED WITH AMPALM-5 AN INTERNAL BLOC
 OF TWO, REALIZING THAT EACH ADDITION TO AMPOR WILL
 DILUTE
 POWER F ALL.

4. AMPALM-5 OPINED THAT PROVISIONAL PRESIDENT SHOULD COME
 FROM AMIRON (AMPOR) TO FIX HISTORICAL ROLE OF AMIRON IN
 ANTI CASTRO STRUGGLE. SAID MEMBERSHIP NOT ESSENTIAL.
 AMPALM-5 THEN ASKED IF BENDER GROUP WOULD VSTO AMJAG AS PROV.

PRESIDENT. [REDACTED] REPLIED BENDER GROUP WAS VETOING NO ONE BUT SUGGESTED THAT AMJAG ENJOYED PERHAPS LESS INTERNAL SUPPORT THAN ANY OTHER FIGURE. AMPALM-5 [REDACTED] SAID HE WISHED TO TABLE A PECULIAR CANDIDATE AND NAMED ARCHBISHOP BOZA. [REDACTED] DOUBTED THAT CUBAN TRADITION WAS SUSCEPTIBLE SUCH FUSION CHURCH AND STATE BUT AMPALM-5 SUGGESTED WEAKLY THAT BOZA AS PRIVATE CITIZEN COULD SERVE.
