1. BECAUSE SMABOVES HAVE ACKNOWLEDGED THAT RODRIGUEZ INFORMATION PRIMARILY OF INTEREST ODYOKE, SMABOVE/1 PERSONALLY AGREEABLE RODRIGUEZ TRANSFER PEPRIME WHENEVER KUBARK DESIRES. SMABOVE/1 INSISTS, HOWEVER, THAT BEFORE HE CAN GIVE FORMAL APPROVAL HE MUST FIRST DETERMINE THAT SMABET HAS NO OBJECTION.
2. ACCORDING SMABEAM, SMABOVE/1 HAS INSTRUCTED THAT SMACT/1 BE "INFORMED" OF IMPENDING TRANSFER MORNING 28 APRIL AND IF SMACT/1 DOES NOT OBJECT KUBARK CAN PROCEED WITH TRANSFER SMABEAM CONFIDENT THAT HE "CAN AND WILL OBTAIN REQUIRED SMABET APPROVAL".
