1. IN RESPONSE YOUR REQUEST WE FUNDING AMICRON ADDITIONAL \$40,000 FOR JUL BUDGET. WILL MAKE DEPOSIT 24 JUL.
2. ABOVE AMOUNT WILL INCLUDE \$26,475 FOR MILITARY STAFF SALARIES NOT YET PAID FOR JUL AND \$13,525 AS LUMP SUM TO COVER INDEFINITE AMOUNT NEEDED FOR "SOME BACK PAYMENTS DUE RECRUITS" AND "15 TO 20 CHECKS" FOR RECENTLY RETURNED MEMBERS STRIKE FORCE. WE COMPLYING THIS REQUEST FOR FOLLOWING REASONS: (A) TO AVOID TERMINATING SALARIES AND DEPENDENCY PAYMENTS WITHOUT ADEQUATE NOTICE, AND (B) TO AVOID FURTHER AGGRAVATING RESENTMENT BY MILITARY OVER HEAVY REDUCTION THEIR DEPENDENCY PAYMENTS AS COMPARED MUCH SMALLER CUT CIVILIAN BUDGET. HOWEVER, REQUEST YOU INSTRUCT AMELCI-CHE TO SUBMIT SEPARATE AND DETAILED ACCOUNTING EXPENDITURES THIS \$40,000 AND REFUND ANY UNUSED PORTION.
