1. HQS AGREES WAVE VIEWS STATED PARA 2 REF. FUTURE RELATIONS WITH ALL UNILATERAL GROUPS CREATED BY WAVE WILL BE BASED ON SUCH CONCEPT. SHOULD KUBARK RECEIVE DIRECTIVE THAT UNILATERAL GROUPS BECOME AMBUD OPS ALL WILL BE TURNED OVER SIMULTANEOUSLY. UNTIL SUCH DIRECTIVE EXISTS HOWEVER FEEL THAT KUBARK FUNDING SHOULD CONTINUE.

2. CONSEQUENTLY WAVE AUTHORIZED MAINTAIN PRESENT RELATIONSHIP WITH AFJ. WAVE MUST MAKE EVERY EFFORT TO CONTINUE ITS FUNDING AND GUIDANCE IN MANNER WHICH WILL AVOID EXPOSURE OF KUBARK SPONSORSHIP. HQS LEAVES TO WAVE DISCRETION POSSIBLE VALUE DELAYING SUPPORT PAYMENTS TO STRENGTHEN COVER OR BENEFIT POSSIBLE CLARIFICATIONS POLICY WHICH MAY OCCUR IN NEXT TWO OR THREE WEEKS.
