1. ANTICRE/2 REPORTED FOLL ITEM OF INTEREST FROM ALBERTO MORA DECERRA. MEETING OF DIRECTORIO REVOLUCIONARIO IS DE MARZO LEADERS HELD IN HOUSE IN MIRAFLORES (PANAAMA) RECENTLY (PROBABLY DEC 55) TO ATTEMPT DETERMINE WHY THEIR GROUP HAS ONLY ONE MAN (FAUPE CHONON) ON CENTRAL COMMITTEE ORGANIZATION. NEAR VIOLENT ARGUMENT ENSUED BETWEEN CHONON AND AMLASH/1 (A/1) WHEN CHONON ACCUSED A/1, RAUL DIAZ ARCUELLES AND OTHER DIRECTORIO MAJORS OF LICENTIOUS LIVING AND SCANDALOUSLY DAMAGING THEIR OWN REPUTATIONS. A/1 CALLED CHONON A SELFISH POLITICAL OPPORTUNIST AND ALLUDED TO HIS COMRADICE DURING THE FIGHT IN THE MOUNTAINS. A/1 CLAIMED BE ONLY DIRECTORIO LEADER WHO HELPED "CHE" GUEVARA GROUP AT THE TIME, DESPITE FACT THIS WAS CONTRARY DIRECTORIO POLICY.
