1. OP ANTRUNK X POSTPONED TO LATE JANUARY SINCE ANTRUNK/9 HAS NOT RETURNED FROM REF TRIP. ANTRUNK/9 ALONG WITH ANTRUNK/5 (FORMER GUIDE WHO TERMINATED MID-63) AND 3RD PERSON LEFT WAVE AREA 21 DEC 64 FOR ANTRUNK INFIL AREA THENCE HAVANA TO RESCUE [ ] AND 3 OTHERS WHO IN HIDING AT HOME IDEN A. AMICE/14 RCVD INFO FROM BOTH WIFE A/9 AND IDEN B THAT FUNDS FOR OPERATION PROVIDED BY AMFAUNA/3 OSTENSIBLY FROM KUBARK. AMFAUNA/3 IS ACSI SOURCE NO. 180 UNDER WHOSE NET VASQUEZ WORKED UNTIL A/3 EXFILTRATED BY ANTRUNKS SEP 63.
