1. MILAT REPORTS AMWEST 2 SAID AMWEST 1 WAS RELEASED FROM HOSPITAL 14 MARCH 66.
2. WHEN TAKING NEWSPAPERS TO HOSPITAL FOR AMWEST 1, AMWEST 2 TOLD MRS. WIGGIN THAT AMWEST 1 WOULD BE VERY CONCERNED ABOUT THE RPTS ON THE GROUP CONVICTED OF TRYING TO ASSASSINATE CASTRO. AMWEST 2 STATED THE GROUP WERE ALL FRIENDS OF AMWEST 1. ARTICLES ON TRIALS APPEARED IN LOCAL PAPERS 8, 9 AND 10 MARCH, AND LISTED ROLAND CUBELAS, RAMON GUIN DIAZ, JOSE LUIS GONZALEZ GALARRETA AND <sup>white</sup> JUAN BLANCO AS PERSONS ON TRIAL.
