1. DESPITE REPEATED TELEPHONE CALLS TO <sup>02</sup> @QHOPS-1 HOME, OLIEN AND LANGOSCH HAVE NOT BEEN ABLE TO TALK TO HIM UP TO AFTERNOON 5 APRIL. HE HAS NOT CALLED OLIEN ALTHOUGH MESSAGES LEFT SO REQUESTED. <sup>02</sup> @QUSPORT-1 REPORT AS DETAILED BELOW ESTABLISHES THAT <sup>02</sup> @QHOPS DID GET THE MESSAGES. ACCORDINGLY IT IS CLEAR THAT <sup>02</sup> @QHOPS IS AVOIDING KUBARK CONTACT.

2. FOLLOWING IS <sup>02</sup> @QUSPORT-1 REPORT OF 4 APRIL MEETING WHICH HE ATTENDED WITH AMWHIP-1, <sup>02</sup> @QHOPS, AMLASH 2 AND AMLASH-3:

A. AMLASH-2 CRITICIZED KUBARK FOR "FOOLING AROUND FOR YEARS WITHOUT HELPING AND FOR JEOPARDIZING AMLASH OPERATION; SAID THAT IF OPERATION FAILS AMLSH GROUP MUST BE PREPARED TO DENOUNCE ADYCKE AS RESPONSIBLE; REQUESTED <sup>02</sup> @QHOPS AND AMLASH-3, BOTH RETURNING PBRUMEN SOON, TO INFORM AMLASH-1 AND FRIENDS OF FOREGOING; SUGGESTED AMWHIP-1 SHOULD BREAK CONTACT WITH KUBARK.

B. AMWHIP-1 EXPRESSED BASIC AGREEMENT WITH AMLASH-2 BUT ADDED THAT HE ON RETURN PBRIME IN FEW DAYS SHOULD PRESENT FINAL DEMAN

ODYCKE; SAID THAT IF AMLASH-1 IS KILLED THE WORLD WILL KNOW THAT ODYCKE IS RESPONSIBLE AND RESULTING SCANDAL WILL MAKE IDEN A <sup>Very Big</sup> ~~VERY~~ INSIGNIFICANT; REMINDED OTHERS THAT HE HAS IMPORTANT FRIENDS INCLUDING IDEN <sup>of name Omar Bradley</sup> SV AGREED TO TERMINATE CONTACT WITH KUBARK IF HIS FINAL DEMAND DOES NOT PRODUCE RAPID CONCRETE RESPONSE.

C. AMLASH-3 ACCUSED ODYCKE OF CLOSING ALL DOORS TO HIM AND BEING RESPONSIBLE FOR DENIAL OF VISA FOR HIM TO GO TO SANTO DOMINGO, AS HE WAS INFORMED BY AMBIDY-1; SAID THAT UNLESS AMWHIP GETS FAVORABLE RESPONSE IN PBPRIME AMLASH-3 WILL REPORT ALL FOREGOING TO AMLASH-1 AND FRIENDS; REPORTED HE, AMLASH-3, IS ON GOOD TERMS WITH IDEN C AND EXHIBITED CODED MESSAGES ON MICROFILM TO ESTABLISH HIS CLOSE CONNECTIONS WITH IDEN C AND HIS SERVICE, MENTIONING IDEN D AS CONTACT WHO FURNISHED CODED MESSAGES. <sup>James Valley</sup> <sup>James Marshall Clarke</sup>
