1. IN REVIEWING WITH VICE SAAL AND LITENPO 2'S REQUEST FOR DATA ON LAT. AMERICAN TERRORISTS TRANSITING MEXICO, APPEARS AS SOME SLIGHT CONFUSION AS TO WHOSE INTERESTS ARE CONSIDERED PRIMARY IN DEVELOPING PERTINENT INFO AND IN DETERMINING WHAT ACTION MIGHT BE TAKEN AGAINST THEM.

2. REQUEST MADE BY LITENPO 2 TO CALBOND AS CITED REF A SEEMS BE ONLY FOR INFO AND BACKGROUND DATA ON KNOWN TERRORISTS IN THE FORM OF VARIOUS LIST FOR WHICH, GIVEN MORE SPECIFIC INFO REGARDING INDIVIDUALS OF INTEREST, WOULD BE MORE USEFUL IN SOME ACTION OF OWN.

3. ON THE OTHER HAND VICE SAAL AND LITENPO 2 SUGGESTS THAT IT IS KUBARK WHO WOULD TAKE ACTION IN ANY GIVEN CASE BY REQUESTING LITENPO 2 TAKE CERTAIN MEASURES AGAINST TRANSITING TERRORISTS.

4. VICE SAAL WOULD LIKE HAVE CLASSIFICATION THIS POINT BY GRASSICK AND, IF YOU THINK IT PROPER TO REOPEN MATTER WITH LITENPO 2, IT WOULD BE USEFUL HAVE FROM NEW ORLEANS INFORMATION AS TO THE EXTENT OF INFO HE REQUIRES AND HIS INTENDED USE OF IT.
