1. ALL INTERESTED HDQS COMPONENTS INCLUDING REPS LCIMPROVE, NYXIS AND TYPIC MATTERS HAVE DISCUSSED OPS VALUE OF REVERSED POST OFFICE BOX LISTING REQUESTED REF. TO MAKE SUCH LIST WILL COST BETWEEN SIX AND SEVEN THOUSAND DOLLARS. IF CONSIDERED CLASSIFIED AND HAS TO BE PURCHASED BY KUBARKERS WOULD TAKE PROBABLY NINE MONTHS. IF NOT CLASSIFIED AND COULD BE GIVEN CENSUS BUREAU OR COMMERCIAL FIRM WOULD TAKE THREE TO SIX MONTHS. ONCE PURCHASED, COULD PROVIDE THREE LISTS, ONE NUMERICAL BY BOX NUMBER, SECOND ALPHABETICAL BY RENTER OF BOX, AND THIRD ALPHABETICAL BY NAME OF PERSON WHO RECEIVES MAIL.

2. HDQS OF OPINION MAIN VALUE OF INFO COLLECTED BY LIZAYAK IS LIST BY BOX NUMBER WHICH ALREADY IS AVAILABLE AND WOULD BE OF USE IN IDENTIFYING BOX NUMBERS FOUND IN MAIL INTERCEPT PROGRAMS, OR PHONE INTERCEPTS. ACCORDING PAST EXPERIENCE, MOST PERSONS OF INTEREST WHO RECEIVE MAIL AT POST OFFICE BOXES RENT THE BOX IN ALIAS AND RECEIVE MAIL ADDRESSED TO ALIAS, THEREFORE ALPHABETICAL LISTING WOULD BE OF LITTLE VALUE UNLESS ALIASES IDENTIFIED.

3. HQS REQUESTS STATION FURNISH TWO COPIES OF ENTIRE LIST TO HQS FOR REVIEW AND EXAMINATION STATION'S REQUEST SET. IN COVERING DISPATCH PLS SET FORTH HOW STATION PLANS USE LIST, FREQUENCY OF EXPENDED USE, AND HOW REVERSE LISTINGS WOULD MATERIALLY SUPPORT THE STATION CE PROGRAMS. THE STATION MIGHT WISH TO WAIT FOR THE REEVALUATED JANUARY LISTING REFERRED TO IN PARAGRAPH ONE REF SO THAT IF REVERSE LISTINGS ARE PROCESSED, IT WOULD CONTAIN CURRENT NAMES. HQS ~~DISREGARDS~~ THIS LIST BE CONSIDERED UNCLASSIFIED FOR PROCESSING PURPOSES SO THAT IF PROCESSED FOR MACHINE LISTING THE STATION CAN RECEIVE QUICKER SERVICE.
