1. IN VIEW POSITIONS SANDIG AND CLAUSSEN PLUS INFO CONTAINED IN REFS C AND D, CONSIDER IT PROBABLE THAT BEER DELEGATION WILL SUPPLY DETAILS PURCHASE 20,000 TONS WHEAT AND POSSIBLY NEGOTIATE FOR MORE WHEAT.

2. ALSO HAVE ODACID REPORT THAT BEERS HAVE DISCUSSED PLAN WITH SWISS BANKERS UNDER WHICH BEER WOULD SELL \$400,000 TO \$500,000 WORTH OF "THIRD COUNTRY" WHEAT TO BRAZIL FOR DOLLARS.

3. PRESERVE EARHOLD REF DELEGATION INDICATES PURPOSE TRIP MAY INVOLVE MORE THAN WHEAT. BEERS PROPOSITION THIS BEER OPEN TRADE OFFENSIVE MEXICO, PERHAPS STARTING WITH BARTER MACHINERY AND PRECISE INSTRUMENTS AGAINST SURPLUS FOODSTUFFS. BELIEVE BEERS MAY PER AMERICAN ESTABLISH PERMANENT TRADE DELEGATION MEXI BEFORE PRESIDENTIAL CAMPAIGN.
