1. ALLAN OXELEY, BRITISH CORRESPONDENT RECENTLY DEPORTED FROM CUBA, DEPARTED MEXI 9 NOV VIA PANAMERICAN FLIGHT 451 FOR MIAMI FLORIDA WHERE HE PLANNED STAY AT DUPONT PLAZA.

2. LIFEAT RPTED 14 NOV OXELEY HAD BEEN IN CONTACT WITH TIME CORRESPONDENT FOR MEXICO DUDLEY DOUST. DOUST ARRANGED LAST MINUTE VISA WAIVER SO OXELEY COULD ENTER U.S.

3. JUST PRIOR DEPARTURE OXELEY TOLD DOUST THAT REASON HE GRANTED VISA WAIVER WAS THAT ODOYKE OFFICIALS MEXICO THOUGHT KUBARK WANTED TO TALK WITH HIM. OXELEY SAID HE WAS "SO MAD WITH KUBARK AND THEIR LITTLE AGENT LIPPER (PHONETIC) THAT I AM GOING TO GIVE THEM AN EARFUL IF THEY EVER COME TO ME". HE WONDERED IF HE COULDN'T SEE KUBARK IF LIPPER WAS WORKING FOR KUBARK AND HE INVOLVED OXELEY RESULTING IN OXELEY'S LOSING 10,000 DOLLARS. OXELEY ADDED "I WILL CERTAINLY ASK KUBARK IF THEY DON'T ANTE UP A FEW THOUSAND BUCKS. I AM SO DAMNED FURIOUS. IF THEY ARE GOING TO EMPLOY THESE SILLY AGENTS WHY DON'T THEY GET SOMEBODY WHO KNOWS WHAT THEY ARE DOING".
