 [WINSTON SCOTT] <sup>HEAD OF</sup> CIA [OFFICE] HERE, JUST ADVISED RECEIPT OF CABLE FROM HIS HEADQUARTERS FURNISHING INFO RE POLYGRAPH OPERATOR. [SCOTT] STATED HIS CABLE FURNISHED DETAILED INSTRUCTIONS TO EFFECT CUSTODY OF [ALVARADO] <sup>SOURCE</sup> SHOULD BE OBTAINED FROM MEXICANS, THAT [ALVARADO] <sup>SOURCE</sup> SHOULD BE FED AND GIVEN A CHANCE TO REST AND THAT INTERVIEW SHOULD BE CONDUCTED ONLY IN PRESENCE OF POLYGRAPH OPERATOR AND THE WRITER. [SCOTT] <sup>CIA REP</sup> SAID HIS CABLE INDICATED THAT THIS SHOULD BE DONE BECAUSE IT MIGHT BE NECESSARY FOR WRITER TO TRAVEL TO WASHINGTON TO REPORT ON RESULTS OF INTERVIEW.

IMMEDIATELY FOLLOWING CALL FROM MR. SULLIVAN THIS OFFICE TOOK INITIAL STEPS TO STOP DEPORTATION OF [ALVARADO] <sup>SOURCE</sup> TO NICARAGUA WHICH WAS SCHEDULED FOR 8 AM TOMORROW. SINCE [SCOTT] <sup>CIA</sup> ORIGINALLY HANDLED TURNING OVER TO MEXICANS OF [ALVARADO] <sup>SOURCE</sup> WHO WAS UNDER CIA CONTROL, <sup>CIA REP</sup> HE TONIGHT IS TAKING UP MATTER OF POLYGRAPH TEST OF [ALVARADO] <sup>SOURCE</sup> WITH [LUIS ECHEVERRIA] <sup>SOURCE</sup> ACTING MINISTER OF GOBERNACION, TO ASCERTAIN WHETHER MEXICANS WILLING TO RELEASE [ALVARADO] <sup>SOURCE</sup> FOR TEST. POSSIBILITY ALWAYS EXISTS THAT MEXICANS MAY FEEL THEIR NATIONAL SOVEREIGNTY BEING INVADED AND THEY MAY INSIST ON HAVING ONE OR MORE OBSERVERS PRESENT DURING TEST.

1. This memorandum responds to reference request and its contents are for the information and use of Mr. George W. Clarke, Assistant General Counsel.

2. Attached, in accordance with reference request, is an unsanitized copy of Division D memorandum FID 113/72 for transmittal to the Department of Justice.

3. Subject Department of Justice request asked, in sub-paragraph 2), that this Agency provide a copy of a memorandum dated 25 February 1972 to the General Counsel requesting a legal opinion "re telephone tickets". A thorough search of our files fails to indicate that such a memorandum was ever written. We speculate that the request to the OGC was verbal. We note, to support this thesis, that the memorandum (sub-paragraph 3) of subject) of James Boylan, OGC, is dated 25 February 1972 and suggest that this memorandum is actually the subject of both sub-paragraphs 2) and 3) of the subject request.
