OF THE PHOTO SURVEILLANCE OPERATION IN MEXICO CITY. EMPHASIS WILL PROBABLY BE ON PERIOD SEPTEMBER-OCTOBER 1963. WHICH COINCIDES WITH VISIT TO MEXICO CITY OF LEE HARVEY OSHALD.
- 2. HSCA INITIALLY PROPOSED TO SEND TWO INVESTIGATORS TO MADRID TO CONDUCT INTERVIEW OF K/1 UTILIZING STATE DEPARTMENT COUNTER-PART FUNDS SINCE THEY HAVE NO FUNDS TO BRING K/1 TO U.S. FOR INTERVIEW.
